

## **Important Disclosures**

### **Location Permits**

If you are planning a beach wedding in Hawaii please be advised that a permit is required in most cases. If you book a wedding or vow renewal based on our A La Carte services we will acquire the permit for a fee of \$45 for up to 20 attendees, \$55 if over 20 attendees, up to a maximum count of 30 for state locations and 40 for City & County.

If you book one of our Preferred wedding or vow renewal packages we will acquire the permit for a fee of \$25 for up to 20 attendees, \$35 if over 20 attendees, up to a maximum count of 30 for state locations and 40 for City & County.

For City & County permits the couple may need to assist us in obtaining a permit for certain locations.

A separate permit may also be required at certain locations for photography. If necessary the permit will automatically be provided at an additional cost of \$20.00.

### **Travel surcharges**

Travel surcharges for each vendor and/or supplier will apply to locations outside of the metropolitan Honolulu area which is from Kawaikui or Kahala / Waialae beach to Magic Island.

If you book your wedding or vow renewal from our A La Carte services the travel surcharges per vendor are as follows: Waimanalo to Kualoa + \$50, Kaaawa, to Haleiwa and Ewa and Ko’Olina +\$75, for Laie or Turtle Bay or the Waianae Coast + \$100.00.

If you book your wedding or vow renewal from one of our Preferred wedding or vow renewal packages the travel surcharges per vendor are as follows: Waimanalo to Kualoa + \$30, Kaaawa, to Haleiwa and Ewa and Ko’Olina to the Waianae Coast + \$50.00.

Travel surcharges for videographers is \$50 for Southeast shore / Windward locations and \$100 for West, East, and North shore locations.

### **Initial deposit and payment options**

We will schedule your ceremony with a minimum initial deposit payment as low as \$100.00 with the remaining balance due at your ceremony, payable either in cash or by certified check made payable to Jade H. Glover.

With our “Pay As You Go” payment option, for a one-time transaction fee of just 2.9% of the total cost of services for your Hawaii wedding or vow renewal you can make an initial deposit equal to 20% of your total cost of services then 4 equal installments payable up to 30 days before your ceremony. ### **Sales Tax**
